## Natur a chynnwys | Scope and content

A manuscript volume containing abstracts of title, [c. 1816] (watermark 1814), relating to the estates of Sir Mark Wood of Gatton, Surrey (formerly of Piercefield, Monmouthshire), in the counties of Monmouthshire and Glamorgan.

The volume is in three sections (labelled A, B and F), abstracting Wood's title to the castle and manor of Pencoed, [Llanmartin], the manor of St Brides [Netherwent] and other properties in Monmouthshire, purchased from Thomas Mathews (pp. 1-106); Mathews' title to leasehold estates in Monmouthshire, including Gillylaes [Gelli-las, Llanfihangel Llantarnam] (pp. 107-145); and a supplemental abstract

of Wood's title to estates in Monmouthshire and Glamorgan purchased from Mathews and others (pp. 146-346). In all some thirty-eight deeds are abstracted, the majority in abstract A. Abstracts A and B also include legal opinions of J[ohn] Holliday, Lincoln's Inn, dated 1794 and 1795 respectively (pp. 105-106, 143-145). The abstracts contain no reference to Wood's ownership of Piercefield, which had been sold in 1800.
